# Objective

University of Milano-Bicocca is a public, multidisciplinary university based in Milan




### T5.2 OS and RDM in the Social Sciences and Humanities (M3-36, OPERAS)








#### **T5.4. OS and RDM in Climate Change** (M3-36, UNITN)
